RESOLUTION 63, 2020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS, FLORIDA, APPROVING THE PALM BEACH GARDENS COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FIVE- (5) YEAR CONSOLIDATED PLAN FOR PROGRAM YEARS 2020 – 2024, INCLUSIVE OF THE YEAR-ONE (1) ACTION PLAN, AND ANALYSIS OF IMPEDIMENTS TO FAIR HOUSING; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, 24 CFR Part 91 requires that the City of Palm Beach Gardens prepares and submits to U.S. Housing and Urban Development (HUD) the Five- (5) Year Consolidated Plan, inclusive of the Year-One Action Plan not less than once every five (5) years in order to receive its annual formula grants; and

WHEREAS, preparation of these documents is a prerequisite for receiving funding under the CDBG Program; and

WHEREAS, U.S. HUD requires that the associated application forms be signed by the City's Administrator for submission to the U.S. HUD; and

WHEREAS, 24 CFR Part 91 and the U.S. HUD Miami Area Field Office require that the Five- (5)Year Consolidated Plan, inclusive of the Citizen Participation Plan, and Year-One (1) Action Plan be duly authorized by the governing body of the City of Palm Beach Gardens; and

WHEREAS, the City Council deems approval of this Resolution to be in the best interests of the health, safety, and welfare of the residents and citizens of the City of Palm Beach Gardens and the public at large.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PALM BEACH GARDENS, FLORIDA, that:

SECTION 1. The foregoing recitals are hereby affirmed and ratified.

SECTION 2. The City of Palm Beach Gardens Consolidated Plan for Program Years 2020 – 2024, inclusive of the Year-One (1) Action Plan and the Analysis of Impediments to Fair Housing, are hereby approved and authorized to be executed for submission to HUD.






